Important to Note before Arriving at the Hospital

1. Doctor's referral is not necessary for the above PCR tests.
2. Our Clinical Laboratory and Pathology (The Laboratory) is a designated COVID-19 test institution recognised by the HKSAR Government.
3. In accordance with the Centre for Health Protection (CHP) reporting guidelines, our doctor will notify the CHP about suspected cases.
4. If your purpose of taking the COVID-19 test is for travelling, please consult the relevant organisations for the entry restrictions and validity period of the test result.
5. In case of disputes, the decision of the Hospital shall be final.

1. 以上核酸測試無須醫生轉介。
2. 本院病理化驗中心獲香港特別行政區政府（政府）列為認可進行新型冠狀病毒的醫療檢測指定機構。
3. 接受檢測人士如符合衛生防護中心2019冠狀病毒病的呈報準則，醫生將通知衛生防護中心。
4. 如因外遊需要檢測結果，請先行向相關機構查詢入境要求及檢測結果的有效時限。
5. 如有任何爭議，本院將有最終決定權。

Q1 What is the "COVID-19 Electronic Testing Record System"?

- A + This system facilitates free download by the general public of their own electronic testing records for the COVID-19 testing. For details, please visit the official website <http://www.evt.gov.hk/>

Q2 How can I get my own testing record from the "COVID-19 Electronic Testing Record System"?

- A + Please submit a completed "2019 COVID-19 Electronic Testing Record System Registration Form" to our Clinical Laboratory and Pathology.
+ One hour after you receive the test report by email from us, please go to the government's "COVID-19 Electronic Testing Record System" website (www.evt.gov.hk) to download the QR code. You may also log in to the "2019 COVID-19 Thematic Webpage" (www.coronavirus.gov.hk) by providing the following information:
- Your identity document type and number
 - Specimen number (Can be found in the attachment we sent you via email)
 - Click "Save" to download the 2019 COVID-19 Electronic Testing Record

Q3 Which test is suitable for travelling to mainland China?

- A + The specimen for COVID-19 PCR test is standardized as followings:
- Nasopharyngeal swab (NPS) for children or infants under 6 years old;
 - Combined nasal and throat swab (CNTS) for adults

Q2 如何從「2019冠狀病毒病電子檢測系統」取得電子檢測記錄？

- A + 請將填妥的「2019冠狀病毒病電子檢測記錄系統記錄同意書」提交到本院病理化驗中心。
+ 於收到本院電郵通知陰性檢測結果後一小時，進入由政府設立的網站「2019冠狀病毒病電子檢測記錄系統」(www.evt.gov.hk) 下載二維碼，亦可透過「2019冠狀病毒病專題網站」(www.coronavirus.gov.hk) 登入該系統；然後輸入以下內容：
- 證件類別及號碼
 - 樣本號碼(可見於醫院電郵附件)
 - 按「保存」以下載2019冠狀病毒病電子檢測記錄

Q3 哪種測試適合香港入境中國內地？

- A + 香港入境中國內地接受以下2019冠狀病毒病核酸檢測採樣模式：
- 6歲以下的兒童和嬰兒：鼻咽拭子 (NPS)
 - 成人：咽喉和鼻腔合併拭子樣本 (CNTS)
