Terms and Conditions

條款和細則

1. Hong Kong Adventist Hospital – Stubbs Road (The Hospital) is an approved Tuberculosis (TB) test clinic by the United Kingdom's Secretary of State for the Home Department through the Home Office. For Hong Kong residents looking to stay in the UK for more than 6 months, a panel physician will screen applicants according to technical instructions provided by Public Health England ("the Screening").
2. The service hours for United Kingdom Pre-entry Tuberculosis Screening are from 14:00 – 16:00, Monday to Friday (excluding public holidays).
3. Please bring the following with you while registering at our Hospital:
 - Valid identification documents, such as a passport or Hong Kong Identity Card
 - 1 passport sized photo taken within the past 3 months
 - For applicants under 17 years old, the applicant should bring their own birth certificate, along with the identification document(s) of their parent(s) or legal guardian
 - Chest X-ray and report (if applicable)The above requirements are subject to the latest changes and announcements by the Hospital.
4. The listed price fees for the Screening includes:
 - 1 Doctor's consultation
 - Chest X-ray (if applicable)
 - Sputum test (pregnant women only)
 - TB Certificate (if appropriate)Please note additional charges will apply for:
 - Any additional testing and/or treatment
 - Reissuance of the certificate due to incorrect or amendment of information (Fee: HK\$450)
5. Sputum test: Collection of sputum (saliva & phlegm) coughed up over 3 consecutive mornings.
6. A chest X-ray or sputum test is required (with additional charges) only for children who exhibit TB symptoms or have a history of TB.
7. Applicants under 17 years old must be accompanied by a parent or legal guardian.
8. To proceed with the booking, applicants must agree to and complete the Informed Consent Form specified by the Home Office documenting your agreement to proceed with the Screening.
9. The Hospital will send a SMS message to notify relevant applicants when the TB Certificate is ready. Applicants can collect TB Certificates within 6 months from the day of receiving the SMS at our Medical Records Department, Service Hours: Monday – Friday (09:00 – 17:30), Sunday (09:00 – 13:30) by presenting the filled and signed Health Records Request Form. Please note that uncollected original certificates will be disposed of after 6 months.
10. Applicants acknowledge that all tests done for the Screening are not for the purpose of medical diagnosis or treatment and accept that the Hospital will not issue the TB Certificate in case any suspected TB symptoms are diagnosed/found. A doctor authorized by The Hospital will make the final decisions regarding examinations. For any suspected TB cases, the authorized doctor has no obligation to provide treatment, but may prescribe a TB treatment referral letter.
11. Applicants are recommended to review the validity of their TB Certificate before departure. The validity period is 6 months from the date of the chest X-ray examination (if applicable).
12. Applicants acknowledge and accept that any relevant personal information collected during the assessment process, including health records and chest X-rays, may be shared with UK immigration authorities, the UK Department of Health, Public Health England, and the UK National Health Service, and shall be retained under our medical record system according to the policies of The Hospital.
13. Hong Kong Adventist Hospital - Stubbs Road reserves the right to update the fee schedule, brochure, terms and conditions. Any change of fee schedule will be announced and notices will be published in advance, in accordance with the statutory notice period. Any other changes except the fee schedule may be made at any time as it sees fit without prior notice, you are advised to check the latest information before using our services.
1. 香港港安醫院-司徒拔道(本院)為英國內政部認可之檢驗診所,為須前往英國超過6個月之香港居民提供英國入境前肺結核檢查服務(有關檢查)。本院醫生會根據英國公共衛生局所提供的技術指引,為申請人士進行有關檢查。
2. 英國入境前肺結核檢查服務時間為星期一至星期五 14:00 - 16:00 (公眾假期除外)。
3. 到診當天,請帶同以下文件到本院登記(如適用):
 - 附有照片的有效身份證明文件正本,例如護照或身份證
 - 最近3個月內拍攝的證件照1張
 - 出生證明書,及父母或法定監護人身份證明文件(適用於17歲以下申請)
 - 肺X光片及其報告(如適用)以上所需文件以本院的最新資料或公布為準。
4. 收費已包括:
 - 1次醫生診症
 - 肺X光檢視(如適用)
 - 痰液樣本化驗(限孕婦)
 - 簽發健康證明(如適用)以下項目須另收費:
 - 計劃以外的檢查和/或治療
 - 因證書上的資料不正確或需要更改,而重發測試證書(費用:港幣450元)
5. 痰液樣本化驗(如適用)須收集連續3個早上的痰液樣本。
6. 如兒童有結核病症狀或結核病史,需要進行肺X光或痰液檢測(需另付費),否則毋須進行。
7. 17歲以下的申請人必須由父母或成年的法定監護人陪同。
8. 檢查之前,申請人必須同意並簽署內政部指定的同意書,以記錄閣下同意進行檢查的協議。
9. 當可領取健康證明書,申請人將收到短訊通知。申請人必須於收到短訊當天起計6個月內,憑已填妥及簽署的醫療記錄申請表到本院病歷部領取(辦工時間星期一至五: 09:00 – 17:30, 星期日: 09:00 – 13:30)。本院將會銷毀逾期未領取的健康證明書正本。
10. 申請人應明白檢查所進行的全部測試並非為醫學診斷或治療目的,並接受如檢查有任何疑似肺結核的症狀,本院將不會發出健康證明書。本院所授權的指定醫生會為申請人進行有關檢查及作專業判斷,並將有最終決定權。如有任何疑似肺結核的症狀,該指定醫生可能為申請人就肺結核治療發出轉介信,且無責任為閣下提供治療。
11. 建議申請人在出發前應檢視健康證明書之有效期,有效期一般為進行肺X光檢查(如適用)後6個月。
12. 申請人亦應明白並接受,評估期間所收集的任何相關個人資料,包括健康記錄及肺X光,或會與英國入境機構、英國衛生部、英國公共衛生局及英國國民保健署分享,且會根據本院政策保留於本院的醫療記錄系統內。
13. 香港港安醫院—司徒拔道保留修訂收費表、單張內容、條款及細則之權利。任何的收費表調整將會根據法定的通知期提前發出通告和作出宣布。其他與收費表以外的相關修訂,則可能不作另行通知,閣下於使用本院服務前查閱最新資訊。
